THE SCHOOL MEALS SERVICE IN THE 21ST CENTURY

The school meals service in the 21st century

The creators of the Welfare State understood the vital role of the school meals service. It was seen as an essential weapon in the armoury against poverty and malnutrition. Food at school during term-time and holidays served health, education and social welfare programmes.

But the 1980 Education Act was to relegate school meals to a non-essential service. The Conservatives had already abolished free school milk for all - a famous and historic attack on social provision. They now removed the duty to provide a midday meal that was 'suitable in all respects as the main meal of the day', introduced in 1944. The Act also abolished the minimum nutritional standards that controlled the quality of school meals and the fixed price 'national charge'. Further legislation reduced eligibility for free school meals.

Other political initiatives, like Compulsory Competitive Tendering, had a negative impact on school meals, even where services remained in-house. This was after being forced to compete on the basis of price and resulted in cuts in staff costs and level of service.

UNISON members are the linchpin of the school meals service. Their skills and commitment are key to its success. But so often they have paid the price when cost-cutting exercises have taken place. Attacks on retainer pay and ineligibility for jobseeker's allowance during the holidays have reduced many to a meagre annual income, with an hourly rate below the statutory minimum wage. And yet, despite being underpaid and undervalued, school meals workers continue to be proud of their service and committed to the children.

UNISON commissioned the school meals survey from the Labour Research Department, which has done a great job in achieving more than an 80% return from LEAs. This means that the following information on the school meals service is probably the best available at this time. The findings suggest that fragmentation is increasing; that standard hot meals are rare in secondary schools; that there is a significant shift to private sector provision and that prices are rising higher than inflation.

We are particularly concerned at the dramatic drop in the number of authorities providing wholly in-house services. We know that the impact on staff of contracting out is mostly a negative one and that new starters on contracts are often employed on inferior pay and conditions.

UNISON welcomed the reintroduction of nutritional standards and an element of compulsory provision in 2001. We also support the government's food in schools programme and share the concern about take-up of free school meals.

But UNISON wants to see even more commitment to a national, comprehensive school meals service; adequately funded, publicly provided and with staff on fair pay and conditions that reflect their worth.

The survey

UNISON commissioned the Labour Research Department to carry out a survey of local education authorities covering a range of issues relating to their school meals service in early 2002.

The main areas in the survey included type of provision, price of meals, service provider (in-house or contractor), subsidies, impact of delegated budgets, nutritional standards and special initiatives such as healthy eating promotions.

There were 168 responses to the survey, accounting for 83% of the local education authorities in England, Wales and Scotland.

The last survey

The last UNISON survey was carried out in 1995. It found a wide range of meal prices – from 65p to £1.25 in primary schools and from 65p to £1.50 in secondary schools. It also found prices rising on average by around five per cent, above the then rate of inflation.

A majority of respondents said that they still subsidised their school meals service but in 38 per cent of cases there was no subsidy and several authorities said they were cutting back on their subsidy.

The majority of services were still provided in-house (70 per cent) with 21 per cent run privately and a mix of in-house and contractor provision in seven per cent of authorities.

Main changes affecting the school meals service

There have been a number of major changes affecting provision of school meals in the last six years. The reorganisation of local government means that there are now 203 local education authorities in England, Scotland and Wales rather than the 128 that were surveyed in 1995. There are now single-tier authorities in Scotland (32) and Wales (22) and 46 unitary authorities in England have responsibility for education along with 36 metropolitan, 34 county councils and 33 London boroughs.

Delegation of budgets means that many schools can choose to run their own meals service directly or to remain part of the LEA contract.

There is also now new legislation covering school meals which requires that they meet nutritional standards. This came into force in England in April 2001 and in Wales in September 2001 but similar regulations do not apply in Scotland.

LEA-wide school meals service

The 1995 UNISON survey found that five local authorities no longer provided a council-wide school meals service. Local management of schools has meant that the break-up of provision is much more evident now with only 80 per cent of respondents now saying that they provide an authority-wide service. Some of these make clear that the coverage of their service is not quite one hundred per cent as some individual schools have opted out of the LEA contract.





Type of provision

LEAs were asked whether they provided standard school meals, a cafeteria service or packed lunches in all or some of their schools.

In primary schools and special schools the standard school meal set up was most common with 71 per cent providing it in all schools and a further 18 per cent providing it in some. A cafeteria service was available as well but only eight per cent provided this in all their primary schools while 20 per cent provided it in some.

The packed lunch option was provided in all schools in 13 per cent of authorities and in some schools in a further 23 per cent. In most cases this was an additional option where meals were also available. However, a small number of authorities, including Buckinghamshire and Dorset, provided packed lunches only.

A cafeteria arrangement was most common in secondary and middle schools with 63 per cent of authorities providing this in all their schools and a further 26 per cent providing it in some schools. Only 13 per cent of authorities provided a standard meal service in all schools with a further 10 per cent providing it in some schools.

In addition to the cafeteria or standard meal service, nine per cent of authorities offered packed lunches in all schools and a further nine per cent offered them in some schools.



Prices

Primary schools

The 1995 survey found that the average price of a primary school meal was £1.03. If prices had risen in line with inflation (from September 1995 to September 2001) then the average would now be £1.19. However, the average in the survey was 12p more at £1.31, well ahead of an inflation-matching rise.

Current prices for primary school meals range from 95p in Dumfries & Galloway to £1.65 in both the City of Edinburgh and the London Borough of Wandsworth.

Middle schools

Only 38 authorities had prices for meals in middle schools and these were often the same as primary school prices. The average price was £1.32.

These ranged from £1.15 in Islington to £1.55 in Norfolk and Northumberland.

special schoolcondary schools the average price in the latest survey was £1.41, up from £1.12 in 1995 and 12p more than if rises had remained in line with price inflation.

Prices in secondary schools range from £1.00 in Dumfries & Galloway up to £1.85 in Edinburgh and Bexley.

Price increases

Nearly a quarter of authorities (23 per cent) do not automatically increase their school meal prices each year. Some of those offering the lowest prices have not made any increases for several years in fact. The last increases in Islington and Shetland were in 1996 and prices in Greenwich and Wakefield haven't changed since 1998.

On average those authorities which did increase prices in 2001 raised them by more than inflation. The increase in the RPI to last September was 1.7 per cent. However, prices in primary schools went up 5.6 per cent on average. In secondary schools the average increase was 3.6 per cent and in special schools it was 2.3 per cent. In middle schools the increase was 3.9 per cent.

Subsidies

It was notable that 59 per cent of respondents said that there was still some form of subsidy for the school meals service and this is in fact very little changed from the 1995 survey. There was an indication then that authorities were moving away from subsidies but this has clearly not happened in large numbers, although these figures have to be treated with some caution because of the significant reorganisation of local government.

The responses on subsidies were very varied with many authorities unable or unwilling to give specific figures for total subsidies or subsidies per meal. In some cases subsidies were given per meal or per primary or secondary meal.

Those authorities charging the lowest prices had some of the largest subsidies. The fixed annual subsidy at Dumfries & Galloway, where primary meals are only 95p and secondary meals only $\mathfrak{L}1.00$, is nearly $\mathfrak{L}720,000$ a year. At Kingston upon Hull primary meals are only $\mathfrak{L}1.00$ but the average cost of providing a meal is $\mathfrak{L}1.51$.

Other examples of high subsidies per meal are: Shetland (£1.02), East Lothian (60p), Southwark (58.3p primary), Hammersmith & Fulham (48p primary), South Ayrshire and East Ayrshire (47p).

On average primary and secondary school meal prices were 4p cheaper in authorities with subsidies while meals in special schools were 7p cheaper in authorities with subsidies.

A full list of the subsidy details provided by respondents is given in Appendix two.

Budget monitoring

With delegation of budgets to individual schools the question about budget monitoring was intended to find out to what extent, if any, schools were ending up with surpluses on their school

meals budgets that were being used elsewhere. Although some authorities thought this may be happening there was little concrete evidence to back it up. Overall the belief was that whenever there was scope for this the likelihood was that any surpluses would be reinvested into the service in terms of spending on equipment or new initiatives.

Several authorities simply said that surpluses were reallocated but gave no further information. These were East Sussex, Kingston upon Thames, Norfolk and North Yorkshire.

In Coventry, the authority said this was highly likely to be the case but that the actual situation was not known. Camden acknowledged the existence of a surplus but said there was no evidence that the slight surplus was allocated to spending elsewhere.

In Dorset, the authority clearly stated that while most of the surplus went back into the catering service, some schools used payment to fund other projects in the school.

A full list of the comments on budgets provided by respondents is given in Appendix three.

Service provider

Seven out of 10 respondents to the 1995 survey said their caterers were in-house only. There has been a significant shift here with only 55 per cent saying that the service was wholly in-house. However, there is a much more mixed picture as privatisation has often taken place where schools have taken on the management of the catering service themselves.

In 21 per cent of responses, catering was provided partly by the in-house service and partly by a contractor. Twenty-three percent of respondents said that the service was completely privatised.

Most contracting out was carried out by English authorities and schools with in-house services dominating provision in Scotland and Wales.





More than 20 different companies were listed as having contracts either with LEAs or individual schools. The Compass Group subsidiary Scolarest was listed as a contractor by 37 authorities (Scolarest is now the main trading name for all Compass Group's catering firms — Chartwells, Eurest, Fairfield etc.). Initial Catering Services (17), Sodexho (13) and Castle Independent (12) were the next most widely used contractors with most other firms only registering a handful of times.

A list of contractors by authority is given in Appendix four.

Nutrition

All schools in England and Wales have to meet nutritional guidelines in their school meal provision. Similar legislation is not yet in place in Scotland.

Authorities reported that they complied with the guidelines through central planning and checking of menus and/or there was specific monitoring of the actual service either by the catering service itself or by the authority in a client role.

While some authorities simply referred in broad terms to monitoring, others were more specific about the process. At Cumbria, for example, there is "monitoring by trading standards food analysts and inspection by client services to ensure rigorous compliance with rigid county specification (with national nutritional guidelines written in)."

Regular site monitoring was mentioned by Middlesbrough, Nottingham, Portsmouth, Rotherham, Warrington, Warwickshire and West Berkshire.

In at least 18 cases authorities used the services of a nutritionist to check menus or monitor provision. These were: Aberdeen, Bath & North East Somerset, Bracknell Forest, Brent, Camden, Cardiff, Denbighshire, East Lothian, Harrow, Highland, Inverclyde, Knowsley, Leicester City, Leicestershire, Manchester, North Lincolnshire, Swindon, Tower Hamlets.

A full list of the comments on nutrition monitoring provided by respondents is given in Appendix five.

Special initiatives

There were 156 responses on this issue with most authorities following the various key initiatives that have been piloted in government projects such as breakfast clubs, fresh fruit schemes and healthy eating promotions.

A small number of authorities had invested money in improving dining facilities (Coventry, Manchester and Renfrewshire) while others had set up cashless systems in secondary schools (Cardiff, Derby, Hartlepool, Stirling, Sunderland and Wrexham).

There was a wide range of other initiatives such as marketing campaigns (Manchester and Torfaen – the latter getting a 12 per cent increase in take-up) regular themed days (Coventry) and open days for parents (Cumbria and Rutland).
